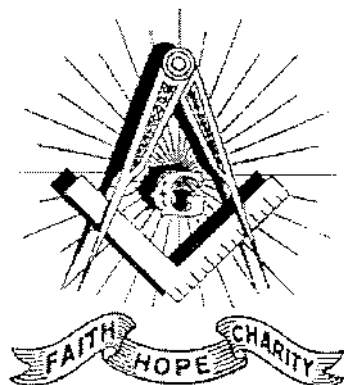

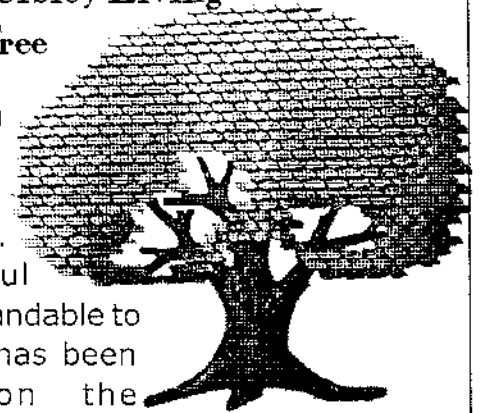
We have a barrel in the lobby of the lodge for food donations for the Shalom Center & THE SALVATION ARMY. The food is much appreciated
