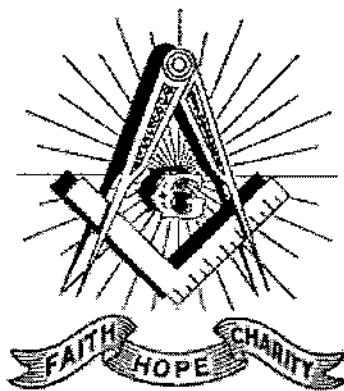
Also, I must report that **Brother Don Roeder lost his darlin' Deedee**. Our sympathies are with you Brother Don.

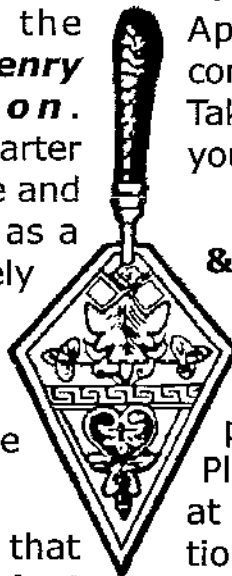

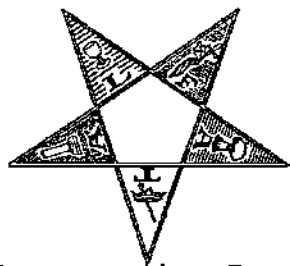

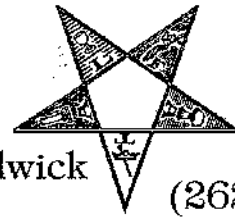
