



Below, please note that there is a revision to one of our by-laws. We will vote on this revision on April 16th. The addition is in **bold** italics. The new version will read:

Section 3. The Stated Meetings of the Chapter shall be held on the first and third Monday of each month, except during the following months: June - The first Monday will be a stated meeting and the third Monday will be a special meeting. July - One meeting held on the third Monday. August - One meeting held on the first Monday. December - One meeting held on the first Monday. If the meeting on the first Monday is cancelled, the meeting will be held on the third Monday.




