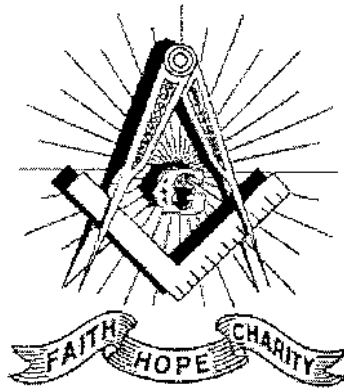

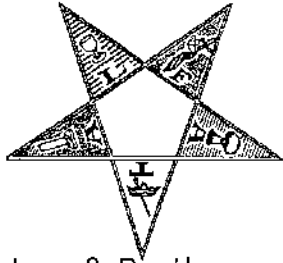

Well, I have been at the computer so long that I didn't have to help load the van. :

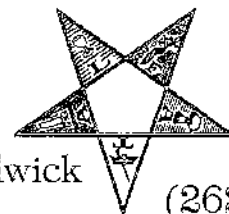

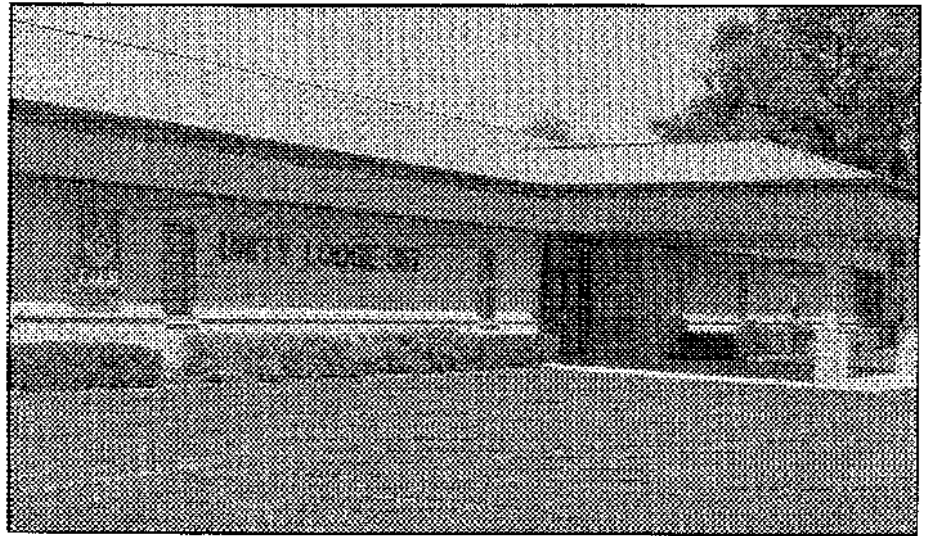
