3) We currently have three (3) Entered Apprentices and one (1) Fellowcraft studying for their advancement.

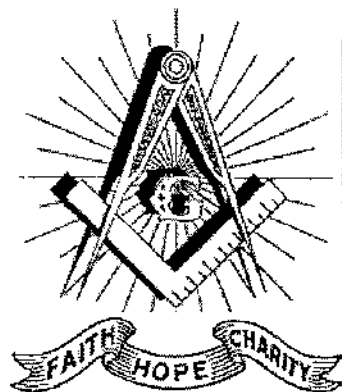
Thus you can readily understand that we are busy at "Work".
