The Raffle is coming! Buy a ticket or two!

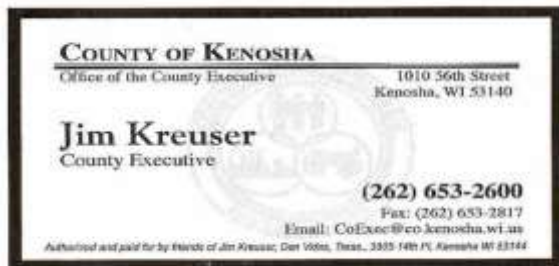
