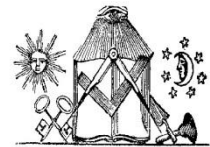
We will be voting on two petitioners at our next stated communication. If successful, we will be scheduling degree work for Sept. 28th. So stay available, as we can use the help.
